Summary Annual Report

Carpenters of Western Washington Individual Account Pension Plan

This is a summary of the annual report of the Carpenters of Western Washington Individual Account Pension Plan, E.I.N. 91-1160641, Plan No. 002, for the year beginning January 1, 2018 and ending December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a Trust. Plan expenses were \$24,518,893. Expenses included \$264,878 in administrative expenses and \$24,254,015 in benefits paid to participants and beneficiaries. A total of 15,231 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits. The value of plan assets, after subtracting liabilities of the plan, was \$479,281,899 as of December 31, 2018 compared to \$483,434,664 as of January 1, 2018. During the plan year, the plan experienced a decrease in its net assets of (\$4,152,765). This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had revenue of \$20,366,128, including employer contributions of \$16,128,903, participant contributions of \$14,044,948, rollover contributions of \$16,017 and losses from investments of (\$9,823,740).
